2. Cookie categories

Category	Purpose	Consent
Strictly necessary	Website operation, security and storage of cookie choices.	Not switched off through consent panel; may be blocked by browser but functions can fail.
Analytics	Measure visits and page use so T&T can improve the site. The current site identifies Google Analytics.	Disabled until affirmative consent; withdrawal must be as easy as acceptance.
Functional	Optional enhanced features, if introduced.	Consent unless strictly necessary.
Advertising/social media	Tracking, embedded marketing or social features, if introduced.	Consent; not to be activated before consent.

3. Current cookie register

4. Choices

Visitors can Accept, Reject or configure non-essential categories. Refusal does not prevent ordinary access to the informational website. Consent is recorded and can be withdrawn through "Cookie Settings". Browser controls may also delete/block cookies.

5. Governance

- No non-essential tag loads before consent.
- Banner does not use pre-ticked choices or make rejection harder than acceptance.
- A fresh scan and notice review follows website/plugin/tag changes and occurs at least annually.
- Consent logs are retained only as necessary to demonstrate the choice.
- Website owner and DPO approve material changes.
